

Training Fees for Full-time Technical Diploma Courses for Academic Year 2025

For new students admitted in AY2025 under the SkillsFuture Mid-Career Enhanced Subsidy

ITE has adopted a **cohort-based fee structure** for full-time *Nitec*, *Higher Nitec* and Technical Diploma courses. Under the structure, a student's tuition fee will remain unchanged for the entire duration of the course. With this, students will have greater certainty regarding the tuition fee and can better plan the financing of their studies.
