

Applicable to *Nitec* graduates attaining the following ITE qualification:

- Nitec in Nursing

To be eligible and be considered for admission to the various ITE courses, you must achieve the minimum **NET** Grade Point Average (GPA) (including CCA bonus points) in your *Nitec* course for the different *Higher Nitec*/TD courses as shown in **Table 1 and Table 2** below.

Some *Higher Nitec*/TD courses also have additional prerequisites, in addition to the course entry requirements. You must fulfil the additional prerequisites to be considered for the relevant courses. Please refer to the footnotes, if any, for the additional prerequisites.

The intake exercises for *Higher Nitec* and TD courses are conducted separately.

Admission into the courses of your choice is based on merit and subject to the availability of vacancies.

Priority in selection for this course will be given to <u>first-choice applicants</u> based on their results. **Applicants applying for this course are recommended to indicate the course as their first choice**. Shortlisted applicants will be required to attend <u>an interview</u> to assess their suitability for the course. Applicants who are unsuccessful at the interview will be considered for their <u>remaining choices which do not require interview for admission</u> based on merit and choice. For all other courses, based on the result of applicants, selection will be by merit and choice. <u>Applicants who are keen in courses with interview are encouraged to apply for a mix of courses with interview and courses without interview in their choices to maximise their chance of posting.</u>

Applicants applying for these courses have to pass a pre-admission medical examination.

All prospective healthcare students must be fully vaccinated against COVID-19 with a vaccine regime recognised in Singapore. Those who are Medically-Ineligible will be subjected to prevailing MOH and healthcare institutions' policies. Those who are Medically-Eligible but wish to remain unvaccinated may not be able to access the healthcare and community care settings to complete their Industry Attachment Module and meet the compulsory internship requirements necessary for graduation or their course completion may be delayed due to restrictions on internship posting to the industry.

Due to the special requirements of the healthcare profession and in the delivery of direct patient/client care, all applicants for this course have to pass a pre-admission medical examination and be free from physical and mental handicap to ensure suitability. Whilst not comprehensive, the following medical conditions will lead to non-acceptance into the course:

- Epilepsy
- Legal Blindness
- Active Tuberculosis
- Profound Deafness
- Psychiatric Condition
- Uncontrolled Diabetes
- Uncontrolled Hypertension
- Uncontrolled Asthma
- Mobility Restricted (Hindering Performance)
- Physical Dependence upon Mobility Equipment

Eyecare practitioners are required to provide care, consultation and management of a patient's vision through eye tests and effective communication. Therefore, good interpersonal skills and good psychomotor ability is required. All applicants for this course must possess the following abilities to perform direct eyecare on clients safely and effectively:

- **Mental-Cognitive ability**, including interpersonal-communication, emotional-behavioural stability to function under stressful work environment, and provide safe eyecare to clients.
- Physical ability to move around in a clinical/retail environment, including standing during service delivery.
- Auditory ability to communicate with patients under normal speaking level sounds.
- Visual ability to read small print on ophthalmic trial lenses and digital display on instruments.

Applicants applying for *Higher Nitec* in Early Childhood Education must also:

- Have obtained a Grade 1 to 3 for GCE 'N' (Academic) English Language, OR Grade A1 to C6 for GCE 'O' Level English Language, OR Grade A for GCE 'N' (Technical) English Language, OR *an English Language Acceptable Alternative (ELAA) recognised by ECDA;
- Pass a pre-admission medical examination. In addition, to ensure the well-being and safety of children, the Early Childhood Development Agency (ECDA) requires all pre-school staff to be certified medically fit to work with young children. More details on the medical examination can be found at http://bit.ly/NIECmedical; and
- Nitec graduates who enrol in the Higher Nitec in Early Childhood Education course, with Grade 1, 2 or 3 for GCE 'N' (Academic) English Language OR Grade A for GCE 'N' (Technical) English Language, without Grade A1 to C6 for GCE 'O' Level English Language (C6L1), are required to obtain C6L1 OR any of the *ELAA, upon graduation before being certified as a Level 1 (L1) Early Childhood Educator. For all courses:

- (I) All *Higher Nitec* courses comprise 6 months of Industry Attachment, except for Nursing which comprises 9 months of Industry Attachment spanning across the 2 years of study.
- (II) As all ITE courses will incorporate online learning as part of lesson delivery, students are advised to have access to a PC/Laptop for their learning. Financial assistance is available to eligible students under ITE Opportunity Fund to purchase PC/Laptop subject to terms and conditions.
