MODULE OBJECTIVES

Foundation Modules

Introduction to the Human Body

On completion of the module, students should be able to identify the key anatomical structures, and describe the primary function and associated common disorders of the various body systems.

Professional Practice in Health Services

On completion of the module, students should be able to articulate the roles and responsibilities of professionals in health services. They should be effective team players and demonstrate professional behaviours based on the code of conduct for health services.

Client Care I

On completion of the module, students should be able to perform and adhere to infection control procedures, monitor and evaluate vital signs, assist in activities of daily living of client, and observe good body mechanics while attending to clients.

Centre Operations I

On completion of the module, students should be able to explain the types of centres in Singapore and perform administrative work. They should be able to observe a client's behaviours and needs, and accompany them for essential appointments. In addition, they should be able to orientate a new client and assist in recruiting and managing volunteers.

Centre Operations II

On completion of the module, students should be able to coordinate with various stakeholders for continual client care, assist with the daily operations of a community care organisation and carry out workplace safety and health procedures.

Introduction to Social Services in Singapore

On completion of the module, students should be able to describe the evolution of the social services sector in Singapore. They should also be able to describe the essential qualities and responsibilities of staff working in the social service sector.

Foundation of Community & Health

On completion of the module, students should be able to describe Singapore healthcare system, explain the concept of community care, describe the transformation of health industry and how support differentiate according to population and health trends/ issues, perform basic health screening, bed making and handling clients in bed.

Introduction to Rehabilitation

On completion of the module, students should be able to describe the roles and responsibilities of rehabilitation professionals. They should acquire basic understanding of the One-Rehab Framework and be able to assist the therapists in the care of patients/ clients during the rehabilitation journey.

Specialisation Modules

Anatomy & Physiology

On completion of the module, students should be able to explain the anatomical structures and primary function, of the various body systems, skin and sensory organs. They should also be able to relate the common terminologies and clinical manifestations of common diseases or disorders.

Programme Management

On completion of the module, students should be able to explain the framework and processes of Programme Management, and understand the role of programmes in social services. They should also be able to assist trained staff to plan and lead community activities or events, as well as to troubleshoot common issues faced by facilitators.

Rehabilitative Services – Physiotherapy I

On completion of the module, students should be able to assist clients with various medical conditions in transfers and use of mobility aids.

Client Care II

On completion of the module, students should be able to assist client with nutritional and elimination needs, perform blood glucose monitoring, assist in administering medication and respiratory therapies, perform physical examination and assessment, render emergency aid, and assist in last office procedure.

Social Services in Singapore

On completion of the module, students should be able to explain the legislative acts and policies pertaining to the social service sector in Singapore. In addition, they should be able to demonstrate basic attending techniques towards clients in the social service sector.

Rehabilitative Services – Physiotherapy II

On completion of the module, students should be able to assist therapists in conducting therapeutic exercises, implement basic outcome measures, application of orthosis and electrical/mechanical modalities for clients.

Group Work in Social Services

On completion of the module, students should be able to assist trained staff to plan and lead group work. They should have an overview of therapeutic group work and its role in social service.

Introduction to Social Work I

On completion of the module, students should be able to explain the helping process and core values of the social work profession. They should also be able to provide an overview of social work practices pertaining to working with children, youth and family.

Rehabilitative Services – Occupational Therapy I

On completion of the module, students should be able to understand the impacts/ effects of common medical conditions on activities of daily living. They should also be able to assist the therapists in training clients/ patients in activities of daily living.

Introduction to Social Work II

On completion of the module, students should be able to explain the ethical responsibilities of social work practice. They should also be able to provide an overview of social work practices pertaining to working with persons with disabilities, persons with mental health issues, people with substance abuse and other addictions, ex-offenders, migrants and the diverse population.

Rehabilitative Services – Occupational Therapy II

On completion of the module, students should be able to assist the therapists in training clients in vocational skills. They should also be able to conduct training in wheelchair mobility and community mobility. They would acquire the knowledge to plan and conduct group activities and home screening to meet clients' needs. They should also be able to monitor the caregiver's ability and well-being.

Industry Attachment

On completion of the module, students should be able to integrate and apply the skills and knowledge acquired at ITE College, and further develop competencies at the workplace.

Cross Disciplinary Core Modules

Communication for Health & Social Services

On completion of the module, students should be able to display effective communication skills to ensure good working relationship within the organisation, different clientele groups and various stakeholders.

Service Excellence in Health & Social Services

On completion of the module, students should be able to understand the concepts of client-centred service delivery, identify and respond to clients' needs and expectations, create and deliver value to build positive clients' experience and increase organisational goodwill.

Diet & Nutrition for Health & Wellness

On completion of the module, students should be able to provide information to clients on their diet and nutrition and encourage them to make healthier lifestyle choices.

Electives (Course Specific)

Disability Studies

On completion of the module, students should be able to assist in managing clients with various forms of disability as well as in improving the quality of life through person-centred services within a community setting.

Geriatric Studies

On completion of the module, students should be able to demonstrate a basic understanding of geriatric conditions and the common problems associated with aging. Students should also be able to use the various types of assessment tools to assess the needs of geriatric clients.

Para-counselling

On completion of the module, students should be able to demonstrate basic para-counselling skills, be a reflective practitioner, document a session and provide basic attending skills as well as display the qualities of a para-counsellor.

Special Needs Education

On completion of the module, students should be able to assist conducting routine schedule lessons, manage a classroom. Students should also be able to assist in managing challenging behaviours. Additionally, students should be able to assist teachers in training activities of daily living and social skills.
